Registration: If you are a:

A) **Current "WRHA – Shapes Corporate" Member**

You will not have to sign a new agreement. You will continue with your current membership and payment schedule.

B) **New Member who does NOT have an agreement with Shapes**

You will need to sign an agreement for this year's corporate plan. Go to any Shapes location of your choice to sign.

Proof of employment will be required.

C) **Current Shapes Member but NOT on the WRHA – Shapes Corporate Plan**
